Paramount Pool & Spa Systems guarantees the PCC2000 Cleaning & Circulation System to clean a minimum of 99% of the pool's total interior area or remove debris as stated within this limited guarantee.

Paramount defines the PCC2000 "System" as being solely comprised of a series of rotating floor cleaning nozzles, downjets, the MDXR3 Debris Removal System, step cleaning nozzles on all steps, benches or other related interior pool & spa features. Pool & spa design, elements or features that prohibit placement of system components will not be considered part of the 99% cleaning guarantee.

The cleaning guarantee of the PCC2000 System is predicated upon the cleaning principal of removal and storage of debris that has been introduced into the pool by natural means excluding acts of God. It is understood that the cleaning concept of the in-floor system is to suspend debris introduced into the pool by natural means and hold it in suspension until the filtrations of the materials has been completed. Therefore, the expressed limited cleaning warranty covers the area in which any debris is not suspended in the pool's interior.

In the event that the PCC2000 System does not clean a minimum of 99% of the pool's total interior area or remove debris as stated within this limited guarantee,

Paramount shall have the option to modify, upgrade, or exchange system equipment at its expense to meet the criteria established in this guarantee.

This guarantee is subject to the System being installed by a Paramount Authorized Licensed Builder and in accordance with Paramount's residential pool certified design specifications and further must include pool equipment as specified by Paramount which meets recommended equipment performance specifications.

This guarantee is for cleaning and debris removal only. All in-floor system components are warranted by separate Paramount warranties. All other pool system components must be in working condition. Nothing in this guarantee creates or modifies warranties for any system components. If replacement is required in out-of-warranty situations, such replacement costs including any replacement parts or service or labor costs are pool owner's sole responsibility.

This guarantee provides for repairs to be made to the System which may affect the overall cosmetic appearance of the pool. In the event that repairs are made, pool owner understands that some cosmetic differences in interior surface and deck may occur, and pool owner understands that Paramount is not liable for any cosmetic inconsistencies.

While optional, most builders offer the 99% cleaning guarantee. The 99% cleaning guarantee requires the pool owner to service and maintain the pool and its equipment as instructed by the Pool Builder and outlined in the Paramount In-Floor System owners manual.

In the event that the System does not clean as represented, pool owner is to contact authorized licensed Builder. All appropriate steps will be made to promptly resolve any cleaning or debris removal issues. The pool owner agrees to furnish required information and assistance to authorized licensed Builder or Paramount representative.

Paramount Pool & Spa Systems' maximum financial responsibility shall not exceed the original retail cost of the PCC2000 Cleaning & Circulation System as charged by the authorized licensed Builder.
